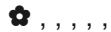

My experience while employed by Michael William Suhar, also known as Mick Williams, in connection with his business operations, including Cyber-Line Radio/Podcast and related entities. During my tenure, I served in multiple capacities, including graphic and web designer, video editor & producer, digital marketing and social media manager, and eventually producer of the Cyber-Line Radio/Podcast show and all associated content.

My responsibilities encompassed a wide range of tasks aimed at promoting and enhancing the Cyber-Line brand. These duties included collaborating directly with Mr. Suhar on marketing strategies, managing online presence across platforms such as YouTube, Twitter, Facebook, LinkedIn, and IMDb, and providing guidance on professional content practices, such as the appropriate use of hashtags and keywords. I also advised on maintaining a professional tone in content to appeal to a broad audience, similar to industry figures like Kim Komando, Kurt Knutsson, Leo Notenboom, and Leo Laporte. Additional responsibilities included voicing advertisements and promotional materials, as well as creating and editing video content.

Despite my best efforts, I encountered significant challenges that impacted my ability to continue in this role. I experienced what I believe to be an unprofessional and unstable work environment, which caused me considerable emotional distress and hardship. Furthermore, I was not compensated for the work I performed. These concerns have been documented with various parties, including medical professionals, the Facebook Oversight Committee, and the FBI. Ultimately, these circumstances led to my decision quit. This statement reflects my professional experience and the reasons for my departure from Mr. Suhar's organization.

Photo attached below shows abuse I received upon quitting. He also illegally added his phone number as my LEGAL agent on IMDb and committed federal crime of mail fraud at my address. He has no regards for the law.
