The following is a description of the various situations, circumstances and scenarios, I portrayed as a role player and a reenactor working for several federal agencies in the area of commercials, training films and videos, industrials, and P.S.A's worked on from 1991 – 2023, in the Arizona, Los Angeles California, District of Columbia, Maryland, and Virginia areas.

As a role player and reenactor my primary responsibility was to accurately portray the characters, bringing them to life and making the suspect or agent real in the eyes of the targeted audience. I portrayed a wide range of fugitives, suspects, refugees, and law-enforcement officers including: ATF, DEA., U.S. marshals, FBI, Coast Guard and CIA agents in the various training videos, P.S.A.s, industrials, and commercials for the various government agencies. I made the characters seem real and authentic as possible, in real life circumstances and scenarios.

**Employment at Government Agencies:**

**Department of Defense / State Department-** (Role Player) for Barbaricum (Washington, DC) and Alutiiq LLC (Alaska)

I played security and other department personnel in exercises for attaché students.

**Department of Transportation (P.S.A)** “Working Smart and Safely”, I portrayed the following characters: an intoxicated middle school bus driver crashing his school bus into a ditch injuring his students; a construction worker unsafely operating a bull dozer while on a cell phone; and a veteran on a motorcycle trying to read a text causing him to run into the back of a parked automobile. The main purpose of this PSA was to emphasize that you must be focused on what you are doing and not get distracted which can cause injury or death.

**Department of Transportation Security Administration:** TSA Agent Industrial) “Professionalism, Courtesy and Respect for Passengers”

I played a passenger in line arguing with a TSA agent rummaging through his luggage. I also role-played a graduate student singled out by the TSA agent trying to board a plane with a stolen ticket and a false ID. This was to showcase courtesy, professionalism, vigilance and security.

**Department of Homeland Security:** (Industrial) “I Am My Brothers Keeper”

I portrayed the following a mentally ill passenger who goes berserk trying to open up an emergency exit door, he is tackled and restrained by the passengers onboard a domestic flight. I also played one of three US Marshalls doing under cover surveillance of three radical terrorist who were suspected of various bombing on a return overseas flight from Turkey to New York JFK airport. We showed the actual techniques and proper procedures to take to notify the authorities at the airport and assist in the apprehension of the three suspects.

**Department of Immigration – (P.S.A)** “We are Always Watching” I played a Mexican smugglers bringing in illegal immigrants in a van across the Mexican border. I also role played a Cuban immigrant (mule) trying to smuggle heroin and cocaine in strapped to his body, through airport customs from South America into the USA.

**The US Customs, ATF and US Coast Guard:** (Training Video) I portrayed the following characters: cartel member, assassin, drug runner, smuggler, and hijacker in a joint task force training videos.

This setup a major surveillance and stakeout sting. that dealt with various terrorist groups and threats who dealt in human trafficking as well as with automatic weapons, ammunition and explosives. Using undercover agents to infiltrate and apprehend various Columbian drug cartels.

**U.S. Coast Guard & U.S. Custom Agency - (Industrial)** I portrayed a member of the Coast Guard crew patrolling the coastal shorelines of Texas, Mexico and Arizona, stopping, raiding and searching incoming pot and heroin drug speedboats. We scrutinized incoming cargo ships for smuggling illegal immigrants from China, Mexico and Africa. As well as raiding and boarding the various smugglers drug boats, searching and inspecting for illegal cargo including endangered illegal immigrants or human trafficking victims such as: women, farm workers, adolescent girls and boys.

**Los Angeles and San Diego Sheriff Departments :** I worked with the Gang Task Force Unit. I portrayed various gang members: MS.-13, Crepts, Bloods, and other militant groups for training videos, films and industrials. The Sheriff department assisted the community by reaching out with various educational programs and kept them updated with information on dangerous gang violence in there area.

**Employment in the Private Sector:**

**Role Player – Hospital Patient Advocate for Interns: Students and Doctors learning how to treat hospital patients:**

I played an actual patient in different hospital situations at the following hospitals: (Cedar Sinai Medical Center, UCLA Medical Center, and Scripps Memorial Hospital). My primary job as a patient was to let the doctor know the type of pain I was experiencing and where I was hurting. This was to train medical students during their internships in how to care and treat patients. The intern's provided their analysis of the situation and determined the appropriate diagnosis and treatment plan. They decided on what procedure to use in the emergency trauma rooms with such situations as; gunshot wounds, attempted suicides, poisoning, broken legs, flu symptoms, and heart attacks victims, etc. This exercise was to simulate real patient-doctor interactions. We were required to give feedback to the Interns as if in a real life hospital situation.

**Role Player – For new Lawyers applying to Law Firms (Greenberg & Better -men; Wine-stock, Friedman & Friedman, P.A.; and Phillips, Morrison, Johnson & Ferrell):**

My primary goal was to get into the mind-set of the client or defendant, displaying various aspects of their personality, attitudes and behavioral characteristics. My main job was to read through the various briefs and trial cases provided by the senior law partner's, with the students. We would summarize actual courtroom cases, then role-played and reenacted the case with the junior lawyer's. We would use real life strategies and techniques to be put into practice during the mock court cases. I role played the following parts: a pimp giving an affidavit and being interrogated by the defense attorney; a boss accused of sexual harassment giving a deposition to his defense attorney; a wall street white-collar criminal pleading innocent to the charge of embezzlement; and a murderer being cross-examine by the prosecuting attorneys. This gave the junior lawyers actual real life hands on experience, in a mock courtroom trial situation or setting that include judges and juries. .

The junior lawyer's main responsibility was to defend victims and to prosecute criminals using supervised, proven techniques and strategies.
