1. Contractor understands that services rendered for Producer will be compensated with a rate of \$ IMDB CREDIT Flat/Hrly/Day. **(Circle One)**. Compensation shall become due and payable within a period of **14 business days** following the final date of invoice received with the Producer.

2. Contractor is hired as an independent contractor. The Contractor shall receive a 1099 form at year-end for wages paid. No taxes will be withheld from wages, and no social security taxes paid. Contractor shall be responsible to pay all taxes as required by law. Company is not responsible to withhold, and shall not withhold, taxes of any kind from any payments due to Contractor, unless Company, in its reasonable discretion, determines that taxes are required to be withheld by any local, state or federal law, rule or regulation.

3. In accordance with the Immigration Reform and Control Act of 1986, any offer of employment is conditioned upon satisfactory proof of applicant's identity and legal ability to work in the United States.

4. Contractor warrants and represents that he or she is free to enter into this license and this agreement does not conflict with any existing contracts or agreements to which Contractor is a

party. Contractor agrees to hold Producer and any third parties harmless from and against any and all claims, liabilities, losses or damages that may arise from the Project.


