**PLEA AGREEMENT AND WAIVER OF TRIAL**

I, Defendant, Eriel Davis, enter into this plea agreement with the State's Attorney's Office of Vermilion County, Illinois, the terms of which are as follows:

1. The defendant is entering a plea of guilty to a violation of the Illinois Vehicle Code, 625 ILCS 5/11-601(b), specifically SPEEDING 1-10, 11-14, 15-20, 21-25 miles over the posted speed limit and will pay a fine of \$50 plus court costs of 228.50 for a total of \$278.50, payable to the Vermilion County Circuit Clerk's Office.
2. The Defendant will be placed on 6 months Court Supervision.
3. At the end of the period of Court Supervision, the defendant will notify the Vermilion County Circuit Clerk's Office by mail the defendant has had no further moving violations, if such be the case.
